The HVS Playground is out of action due to damage. It is non-compliant with the latest (2015) safety regulations. An inspector will visit to assess whether modifications can be made to meet regulations.

The sandpit also needs to be fixed (e.g. a new roof).

Swimming has started and is going well.

The staff are enrolled in Te Puna Reo - to learn Te Reo Maori. The school is looking at how the programme can be opened up to parents in the future. In the meantime, there could be opportunities to add te Reo Maori phrases to the newsletter.

Also noted that snapfish books and year 6 bus expenses were higher than allocated. We noted that we need to adjust allocations for snapfish books for 2024 as costs have increased significantly in recent years.

- We made the decision to make the payments as invoiced by the school to date and reduce the available fund for t-shirts to \$240 total (another \$80) to keep within our limits. This way the school was reimbursed for costs to date, rather than receiving a part-payment.
- The bus error was an error on our side, we did not realise it was \$480 per bus and instead only logged \$480 total.
